 Ride Release and Acknowledgement

Every participant in the ROCKY MOUNTAIN CHALLENGE – 2008 Canadian Nationals shall carefully read and sign this notice, release and acknowledgement. No participant shall be allowed to compete without signing and returning this form to the organizing committee. Should any participant have any questions or concerns as to its intent or legal effect it is recommended that they obtain independent legal advice.

In this Release and Acknowledgement “**inherent risks of equine activities**” shall mean those dangers or conditions which are an integral part of equine activities, including but not limited to:

- (1) the propensity of an equine to behave in ways that may result in injury, harm or death to persons on or around them and/or damage to property in their vicinity;
- (2) the unpredictability of an equine reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
- (3) the equine response to certain hazards such as surface and subsurface objects;
- (4) collisions with other equines, animals, people and objects;
- (5) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or to act within his or her ability;
- (6) the remoteness of the activity which involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; and
- (7) the reality of natural and manmade hazards which include unpredictable weather conditions which a ride management, organizer or anyone connected thereto cannot anticipate, identify, modify or eliminate.

I/We the undersigned, in consideration of being allowed to participate in the **ROCKY MOUNTAIN CHALLENGE – 2008 Canadian Nationals (the Event)**, do for myself, my heirs, my executors and administrators, hereby release, indemnify and hold harmless the Board of Directors of the Rocky Mountain Challenge - 2008 Canadian Nationals, along with their sanctioning association(s), their participating property owner(s), organizing committee(s), officials, volunteers, staff, members, exhibitors, competitors, owners, agents and representatives from and against any and all loss, costs or expenses of whatever nature arising from, or on account of, or by reason of my participation in this Event. It is acknowledged that such release extends to, but is not limited to, any accident, damages or claims arising out of my entry caused by my own act, the acts of others, or any animal within or beyond my control and is valid for my animal(s), my personal belongings, family or guests in my company. I agree to take full responsibility for myself and the mount on which I am riding.

I/We acknowledge and agree that equestrian sports do involve **inherent risks** (as outlined above) and hereby acknowledge and agree to assume all risks and liabilities associated thereto. As a participant in the Event, the undersigned agrees to abide by the rules of the sanctioning and/or related associations (CALDRA, CEF, AERC, FEI, AHA, TRAC and/or ERA).

Entry into the Canadian Championship RNT will be limited to Canadian **CaLDRA** members; otherwise all rides are open to anyone.

- Entry fees include lunch and dinner to all competitors on day of competition.
- Purchase of dinner meal tickets are for dinner on July 31 thru Aug 3 and are not valid for Banquet dinner on Aug 4.
- A Junior rider (who is under 16 years as of Jan 1, 2008 must have a sponsor rider).
- **Mandatory for ALL riders** is the wearing of helmets and use of proper footwear or breakaway/caged stirrups, while mounted.

Cancellations/ Refund Policy:

- Late entry fee of \$20.00 applied to all entries received post marked later than June 30, 2008.
- All cancellations **MUST** be in writing (fax or e-mail). Phone cancellations will not be accepted.
- Once a Championship Team is entered, it may not be withdrawn. There will be no refunds of Team entry fees after the fees are sent in.
- Cancellations received before the closing date of (June 30th, 2008) will be refunded totally, minus \$20 office fee. Cancellations received between June 30 and July 14, 2008 will be 50% refunded.
- Cancellations after July 15, 2008 will not be refunded.
